Director's Report

Kelly reported the following:

The new 5-year lease for the building has been viewed by both the Executive Committee and the Department attorney, Mike Polk. There will be no increase in rent for term of the new lease; Kelly will sign and return to the landlord.

The auditors used by the Department, Schliesmann, Onken & Associates, sent a three year engagement letter. After discussion, the BOH would like Kelly to solicit bids from other firms to do the annual audit.

Radon Awareness Month: 80 radon test kits have been given out at the office. Tedder noted that he was very happy about the amount of advertising that was done to get the word out to the community.

Scott Larson has been contracted as the facilitator for the February 27, 2012, Strategic Planning session for the BOH. There is a fee of \$300-\$400.

With the Legislature back in session, every Friday morning the local health directors participate in a conference call to discuss the bills that relate to public health. They are supporting the following:

Counties keep the inheritance tax.

LB 125: Creation of the Children's Health Advisory Committee

LB 436: Raise tax on cigarettes from .64 to \$1.99 per pack

LB 1123: Increase the availability of fresh fruits and vegetables in underserved areas, both rural & city.

LB 1047: Safe injection practices

LB 925: Requires HHS to set guidelines that money coming into the State, local agencies like health departments are to be given priority before looking out of State. This reflects back to the Every Woman Matters grant a few years back. HHS contracted with two out of State agencies to do the work.

Monitoring:

LB 267: Require a limit to the types of beverages purchased with the SNAP fund

LB 192: Require school districts to offer instruction in sex health education

Looking at:

LB 1038: Testing lead levels in children before they start school

There is one new active TB patient that Monica Ulses, Public Health Nurse. Dr. Strohmyer gave kudos to Ulses for the great job she does for the Department.
