LB 1219 – Extra Pubic Health Funding has been indefinitely postponed. The original request for all Health Departments across Nebraska was for \$7.4 million. The Public Health Association of Nebraska and the lobbyist decided to decrease dollar amount to \$1.8 million. Kelly will be kept posted on any changes with this bill.

Kelly distributed information from a meeting between the Local Health Directors and State Public Health Officials.

Kelly distributed information regarding efforts to prevent unintended pregnancy in Nebraska. It was the consensus of the Board that Kelly, move forward on this issue while recognizing the sensitivity of the issue. Gay and Roberts volunteered to meet with Kelly to provide additional assistance.

Kelly informed the Board that she has been in touch with various banks in Sarpy and Cass counties about reinvesting department monies and that she will report on the results at a future meeting.
